- Work completed by a governmental subdivision or state agency costing less than \$15,000.00

Section 23a of the state construction code act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to person who are to perform work on a residential building or residential structure. Violators of Section 23a are subject to civil fines.

**VI. Homeowner Affidavit**I hereby certify the electrical work described on this permit application shall be installed **by myself in my own home**, in which I am living or about to occupy. All work shall be installed in accordance with the State Electrical Code **and shall not be enclosed, covered up, or put into operation** until it has been **inspected and approved** by the Electrical Inspector. I will cooperate with the Electrical Inspector and assume the responsibility to arrange for necessary inspections.

**Item #17 – Mobile Home Unit Site:** When installing a site service in a park, the permit application must include the application fee, service, the number of park sites and a final inspection. When setting a HUD mobile home in a park, a permit must include the application fee, service, feeder and a final inspection. These shall be done by a licensed electrical contractor. When setting a HUD mobile home or a premanufactured home on private property, a permit must include the application fee, service, feeder and a final inspection.

**VIII. INSTRUCTION FOR COMPLETING APPLICATION**

GENERAL: Electrical work shall not be started until the application for permit has been filed with St. Clair Township. All installations shall be in conformance with the State Electrical Code. **No work shall be concealed until it has been inspected.** When ready for inspection, please call the Township with permit number & job location.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED AND CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION, CLOSED/CANCELLED PERMITS WILL NOT BE REFUNDED.**
