VI. Homeowner Affidavit

VIII. INSTRUCTION FOR COMPLETING APPLICATION

GENERAL: Electrical work shall not be started until the application for permit has been filed with St. Clair Township. All installations shall be in conformance with the State Electrical Code. No work shall be concealed until it has been inspected. When ready for inspection, please call the Township with permit number & job location.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CLOSED AND CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION, CLOSED/CANCELLED PERMITS WILL NOT BE REFUNDED. Concrete electrodes inspection

ELECTRICAL REQUIREMENTS FOR NEW CONSTRUCTION.

Electrician must install one of the below concrete encased electrodes. Arrange for inspection ,prior to concrete placement.

NEC. 250.52 (3), (1)or(2)

Option #1

Connect to a 20 Foot continuous length of $\frac{1}{2}$ " diameter bare or plated ,uncoated reinforcing rod located horizontally in the bottom footing. Connection must be free of rust or slag. Connect by exothermic welding or an approved connector for the purpose. Encased by a minimum of 2" of concrete. That portion of the grounding electrode conductor that is the sole connection to the rod, shall not be required to be larger than #4 copper wire.

Option#2

Place A 20 foot continuous length of bare #4 minimum copper wire, lay horizontally in the bottom footing. Encase by a minimum 2" of concrete.
